SERVICES, POLICIES, AND FEES

To ensure that the practices of therapeutic services are clear, a statement of services, policies and fees are listed below. Please review this policy, sign, and return to Milestones Educational Therapy Institute. Keep the other for your records.

GENERAL INFORMATION

Please have your child arrive promptly at the pre-arranged time and plan to pick up your child promptly at the end of each session. All sessions are **50 minutes** in length unless otherwise agreed upon.

ATTENDANCE/MAKE-UP

Your child's sessions are considered standing appointments. This special time is a commitment on your part and Milestones Educational Therapy Institute. A child's rate of steady progress and growth is highly dependent upon regular attendance. If a child must be absent, the session should be rescheduled within the same week.

CANCELLATION POLICY

We maintain a strict **24 hour cancellation** policy. When you begin services a commitment is made between Milestones Educational Therapy Institute, the therapist and your family. The same time is set aside each week; we require that every effort is made to attend those sessions. Consistency is important for the child and the therapist.

Please email to cancel if you are unable to keep an appointment. **One** cancellation per month is permissible due to illness or other unforeseen circumstances. You will not be charged for this session.

No-shows:

Appointments are a contract for the exclusive use of the therapist's time. Parents will be charged the **full session** rate for no-shows. Please email or call to cancel if you are unable to make an appointment.

Illness:

In the case of illness children need to be 24 hours fever free to return to the clinic. A fever indicates that a child is ill and contagious. We are unable to expose the therapist and other children to the illness.

Schedule of Fees:

Payment for an assessment is required in full on the day of service. Payment for all educational therapy services is required on the **first of the month**. We accept American Express, Visa, Mastercard, debit card, ACH bank transfer, cash, check, and Zelle at **Milestonesedtherapy@gmail.com**.

A 3% service fee will be added to all payments by credit card. This service fee will not apply to payments made by debit card, ACH bank transfer, Zelle, cash, or check.

Fees for educational therapy services will be charged for the upcoming month. If your child receives services twice a week, you will be charged for 8 sessions. If paying by cash or check, payment is required by the fifth of the month or by the first date of service for the month, whichever is first. If there are more or fewer than 8 sessions in a month, you will be notified by email of the total number of sessions and fees.

EDUCATIONAL THERAPY SERVICES

Educational Assessment - \$2,500.00

Assessments are individualized and include approximately four hours of direct assessment, approximately 1 hour parent consultation and approximately two hours for interpreting, scoring and a written report.

Individual Clinic Based Educational Therapy - \$195.00 per session hour

Individual therapy is 50 minutes of direct contact with you and/or your child per session hour. At times, there may be information that you or the therapist needs to share. As your child's therapy is scheduled for 50 minutes, you may request that your therapist set aside time during the treatment to discuss any concerns or questions you may have. Some children require additional time for transitioning to leave after the session and some sessions require additional clean-up time following the session. Any remaining time will be used for the therapist to document treatment outcomes.

Meetings/Travel

When services are provided off site there is a travel fee. For local travel (within 5 miles) in the Los Angeles area the fee is \$25.00. For travel outside of our local area in a 5-10 mile radius the fee is \$75.00. For every additional 5 miles of travel, the fee is raised by \$50.00 increments; for example, if travel is 25 miles the fee is \$225.00. We want to work in a collaborative manner with parents and other professionals. We are happy to try to arrange our schedule (if possible) to participate in meetings, school visits, etc.

Late Pick-ups

While we realize there are times a parent or caregiver may need to leave the clinic during the therapy session, we cannot have staff available and be responsible for monitoring/supervising the child once the therapy session is over. Therapy sessions are 50 minutes in length. Additional time will be pro-rated at regular therapy rates.

Discontinue Services

If you plan to discontinue services, we would greatly appreciate a two weeks notice.
